#### **Event Rules:**

- 1. Child must be age 4 to 8 years old and weigh less than fifty (50) lbs at weigh in 7/18/2009.
- 2. Child Safety Helmets & Vests are PROVIDED and MUST be WORN. NO SPURS ALLOWED!
- 3. TWO COMMITTEE MEMBERS PER CONTESTANT WILL BE IN THE MOUNTING AREA.
- 4. Child may request a girth rope (put on by COMMITTEE MEMBER ONLY) or take a wool hold.
- 5. Child is to grasp with both hands during ride (No extra points are awarded for one hand rides).
- 6. Child MUST STAY MOUNTED for six (6) seconds in order to score and receive ride points.
- 7. Ride points are awarded by a ride Judge for form, difficulty, speed and quality of ride.
- 8. DECISION OF JUDGES IS ABSOLUTELY FINAL. Winners will be announced at the Stadium.
- 9. Trophies will be awarded to the top three riders; all other riders receive Participant Ribbons.

#### ANY VIOLATIONS OF THESE RULES WILL RESULT IN DISQUALIFICATION.
